**LETTER OF AGREEMENT**

**On the implementation of the regional project on the Smuggling of  
Migrants: Establishment and Operation of a Coordination and  
Analysis Unit (CAU) for East Asia and the Pacific**

The Government of the Republic of Indonesia agrees to participate in the implementation of the Regional Project developed by UNODC/RC Bangkok called "The Smuggling of Migrants: Establishment and Operation of a Coordination and Analysis Unit" (CAU project) attached to this letter.

The main objective of the CAU project is to support Member States, as appropriate, and based on demand, to:

- Establish and make operational, systems to generate, manage, analyse, report and use migrant smuggling information.

In so doing, the implementation of the CAU project will contribute to establishing a framework for enhanced collaborative action by Member States to identify and effectively act against smuggling of migrants activities in East Asia and the Pacific.

The CAU project document is a management tool that outlines how the project will be implemented and what are the expected results. It also serves the purpose of a resource mobilisation both for UNODC (in terms of attracting donor funds and accounting for their use) as well as for participating Member States (in terms of mobilising domestic support and resources and accounting for their use).

UNODC support to a participating Member State will only be provided upon prior request of that participating Member State, and will be provided under the general legal framework currently in place governing the cooperation in technical assistance between the United Nations and the requesting participating Member State.

UNODC being a United Nations agency directly attached to the United Nations Secretariat, the purpose of this Letter of Agreement is to facilitate the implementation, as described in the above paragraph, of those technical activities of the CAU project that the Government of the Republic of Indonesia would be desirous to see delivered on its territory, in full compliance with all provisions and conditions set forth in the agreements and other legal instruments currently in force between the United Nations and the requesting Member State.

The UNODC Regional Centre and the Government of the Republic of Indonesia, both signatories of the present Letter of Agreement, recognize and agree that the present Letter of Agreement does not imply any derogation or modification of any sort to the provisions and conditions under which activities carried out by United Nations agencies in Indonesia are currently delivered.


In the event that the implementation of a specific activity under this project poses any difficulty of a legal nature in relation to liability, the signatories agree that such activities will not be delivered on the territory of the State of Indonesia or will be suspended until an official agreement has been reached.

Any relevant matter for which no provision is made in this document shall be settled by the parties concerned in accordance with the relevant resolutions and decisions of the appropriate organs of the United Nations and the State of Indonesia.


