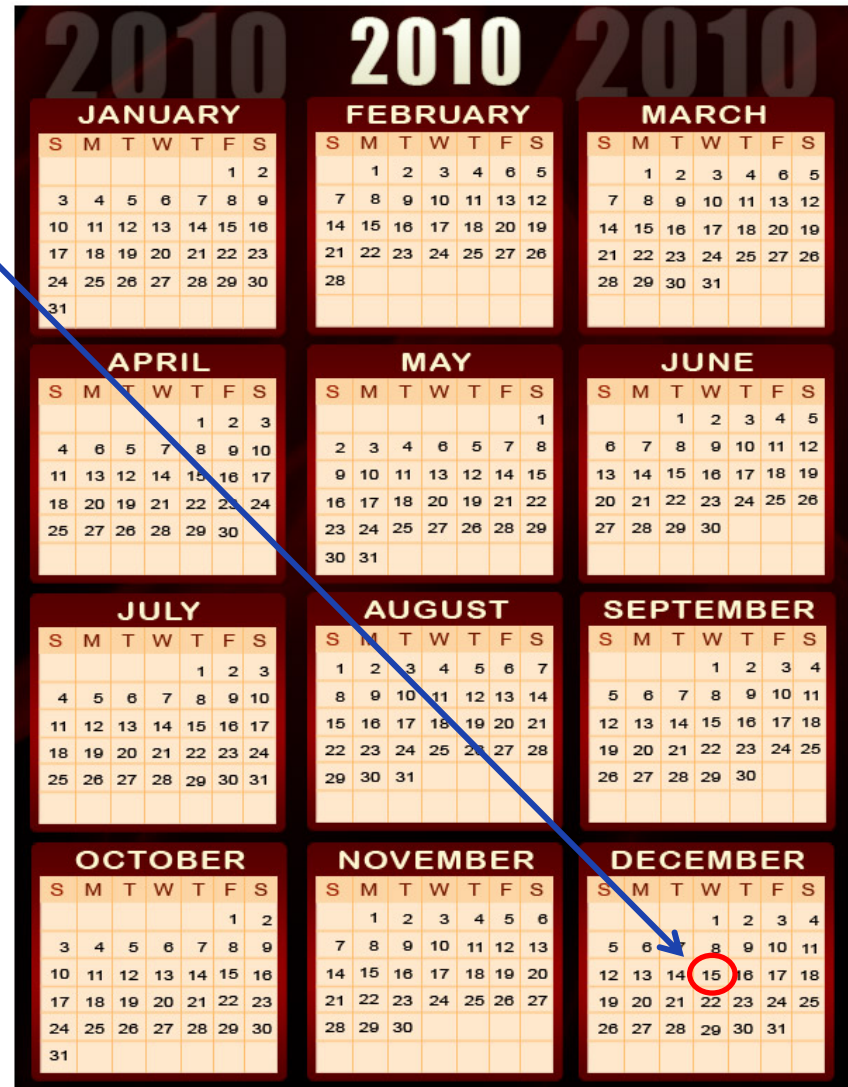

- 1. It should be consensus among law enforcement officers, from the relevant agencies, especially in order to control precursors:**
 - a. Make the MoU among related institutions.**
 - b. Completion of the online information system.**
 - c. Reconciliation data among agencies.**
 - d. Make legal framework (of Government Regulation) on the distribution of non-pharmaceutical precursor.**

- 2. Need an agreement among the officers and rehabilitation therapy data from relevant agencies, especially in the context of monitoring the number of victims of drug abusers who used and methods applied.**
 - a. Strengthening the commitments in the pilot project of 15 Provinces.**
 - b. BNP provide feedback reports to the government's agencies.**
 - c. Improving the ability of Human Resources in the field of recording.**
 - d. Certification taker - disclosure and ethics.**
 - e. Individuals recording level by using a finger print.**

- 3. Officers need to be agreement among forensic data from relevant agencies, in order to monitor the development of the evidence of narcotics use, ranging from the physical condition up to the level of purity of the samples:**
 - a. Make case data and qualitative data periodically narcotics and psychotropic substances as well as the availability of reference standards and analytical instruments to support the quantitative test (drug profiling / impurity profiling).**
 - b. Make SOP analysis according to the category of analysis (raw materials and specimens) by creating a working group UNODC standards.**

- c. Training laboratory personnel in order to improve analytical skills and aid analysis instruments (GC-MS HPLC).**
- d. Build networking/networking between the laboratories and investigators projusticia both at central and regional/province.**
- e. Cooperation between the UNODC with the Ministry of Health (support and yanfar), Agency for Food and Drug Administration and the National Narcotics Agency for projusticia laboratory standard reference distribution.**
- f. Facilitate training for investigators sampling.**
